STATEMENT BY THE DELEGATION OF KYRGYZSTAN

Mr. Chairperson, Distinguished participants,

Allow me to welcome the Secretary General of the Cooperation Council of Turkic Speaking States (CCTS), Mr. Halil Akinci, to the OSCE Permanent Council and thank him and his team for their fruitful work in the CCTS, and for his substantive statement at today's meeting.

In a globalized world and at a time of shrinking distances and mutual rapprochement of nations, no single State or nation can remain on the sidelines of what is happening in the world. The CCTS is designed to identify common interests and examine questions concerned with improving prosperity and protecting regional peace and stability, humanitarian standards and cultural heritage.

As you know, Kyrgyzstan is currently chairing the CCTS. In August of this year Bishkek hosted the second CCTS summit, where the four Turkic-speaking States signed agreements on the creation of a Turkic Academy in Astana and a Foundation of Turkic Culture and Heritage in Baku along with an agreement on the financial rules of the CCTS. The Bishkek Declaration was also signed. These and other important Council decisions once again testify to the growing rapprochement of the Turkic-speaking States.

The Council brings together four States, although there are 40 Turkic-speaking countries in the world, with a population of 200 million. The four countries of the Council fully understand and agree on practically all issues. And we intend to continue effective co-operation and search for joint ways of resolving the issues that affect the national interests of the four countries. All the CCTS participating countries have recognized the importance of joint strategic partnership. We share the view that a priority in the relations between our States is unity for the good of our fraternal peoples because the links between our States are based on common historical, cultural and moral values and on a common language group.

Distinguished participants,

I cannot but mention the following.

As you are aware, the OSCE Ministerial Council meeting in Dublin was unable to ensure the participation of the CCTS and the Parliamentary Assembly of Turkic-Speaking Countries (TURKPA) as invited organizations alongside other international organizations. And we called attention to this matter in our interpretative statement. However, we are not making an issue out of this. A similar situation occurred exactly a year ago during the previous Chairmanship.

We sincerely hope and truly welcome the prospect that this matter will be resolved positively during the forthcoming Ukrainian Chairmanship.

In conclusion, we once again urge the OSCE participating States to support us.

INTERPRETATIVE STATEMENT UNDER PARAGRAPH IV.1(A)6 OF THE RULES OF PROCEDURE OF THE ORGANIZATION FOR SECURITY AND CO-OPERATION IN EUROPE

By the delegation of Kazakhstan:

"Mr. Chairperson,

In accordance with the OSCE Rules of Procedure, paragraph IV.1(A)6 and with regard to the decision just adopted by the Permanent Council on the mandate of the OSCE Centre in Astana, Delegation of Kazakhstan would like to make the following interpretative statement:

Delegation of Kazakhstan joins the consensus on the decision of the Permanent Council on the mandate of the OSCE Centre in Astana. Taking this opportunity we would like to reiterate that Kazakhstan attaches great importance to efficient and effective functioning of the OSCE Centre in Astana.

The programmatic activities of the Centre should be transparent, accountable and result-oriented.

In order to increase transparency and effectiveness of projects implemented, evaluation of the Centre activities in overall and its each project should be conducted on a regular basis. This evaluation should be based on certain outputs/benchmarks outlined in a project. Follow-up to projects should also be exercised.

Moreover it is important that throughout the process of preparation of the Centre's Programme Outline as well as budget and projects development, governmental bodies of Kazakhstan are consulted. Let me stress yet again that co-operation and participation of governmental bodies are key to successful implementation of projects.

Finally the activities of the Centre should be focused, as stated in the Istanbul European Security Charter, on providing assistance and advice or formulating recommendations in areas agreed by the OSCE and the host country. Capacity-building of the host country with the view of gradual transfer Centre's functions to the host country in the foreseeable future should be at the core of every project it implements.

III. Timetable and other organizational modalities

The Conference will begin at 9.15 a.m. (opening session) on 18 March 2013 and end at 1:30 p.m. on 19 March 2013.

The opening and closing sessions will be chaired by a representative of the OSCE Chairperson-in-Office and a representative of the host country.

Each session will have a moderator and a rapporteur. The consolidated summary will be forwarded to the Permanent Council.

Rules of procedure and working methods of the OSCE will be applied, *mutatis mutandis*, to the Conference.

The opening and closing sessions will be open to the media. The Conference will be held in Adelaide, Australia. The working language will be English.

On the margins of the Conference, a side event on regional security architecture in Asia may be organized.
