DECISION No. 6/11 VIENNA DOCUMENT PLUS ACCURACY OF CO-ORDINATES OF FORMATIONS, COMBAT UNITS, AIR FORMATIONS AND AIR COMBAT UNITS

The Forum for Security Co-operation (FSC),

Reaffirming that the OSCE Vienna Document 1999 remains a key instrument for confidence- and security-building measures (CSBMs) and noting the determination of the participating States to update, as necessary, and revise the Vienna Document 1999 with particular attention to strengthening current CSBM instruments,

Implementing Ministerial Council Decision No. 16/09, which calls on the FSC, *inter alia*, to strengthen the Vienna Document 1999,

Seeking to update the Vienna Document 1999 in accordance with the principles delineated in Decision No. 1/10 on establishing a procedure for incorporating relevant FSC decisions into the Vienna Document,

Using the text of the Vienna Document 1999 as a basis for amendments and additions,

Decides to amend the contents of paragraphs (10.2.3), (10.5.2) and (10.5.3.2) of Chapter I, Annual Exchange of Military Information, to read as follows:

(10.2.3)	-	the normal peacetime location of its headquarters indicated by exact geographic terms and co-ordinates accurate to the nearest 10 seconds;
(10.5.2)	-	the normal peacetime location of the headquarters indicated by exact geographic terms and co-ordinates accurate to the nearest 10 seconds;
(10.5.3.2)	_	its location indicated by exact geographic terms and co-ordinates accurate to the nearest 10 seconds.
