DECISION No. 1072 SCALES OF CONTRIBUTIONS FOR 2013–2015

The Permanent Council,

Recalling Permanent Council Decision No. 1027 of 22 December 2011 on the Scales of Contributions for 2012,

Acknowledging the work done in the Advisory Committee on Management and Finance to build consensus on a revision of the OSCE Scales of Contributions,

Noting the reports of the Chairmanship to the Permanent Council on the implementation of Permanent Council Decision No. 1027 on the Scales of Contributions for 2012 (CIO.GAL/66/12, PC.ACMF/34/12),

Reaffirming the need for a stronger application of the principle of fair geographical distribution in recruiting staff,

Bearing in mind that the changing economic and financial situation in the OSCE area affects substantially the national budgets of participating States,

Regretting the absence of a regular mechanism to revise the Scales of Contributions according to economic conditions,

Determined to work out an agreed and sustainable formula for the future revisions of the Scales of Contributions,

Reaffirming the principle that all participating States should in good faith fulfill their financial obligations towards the OSCE, including the settlement of arrears,

- 1. Approves the standard and field operations Scales of Contributions as contained in the annex, from 1 January 2013 to 31 December 2015;
- 2. Decides to undertake a comprehensive review of all elements and criteria with regard to the Scales of Contributions in an effective and expeditious manner with a view to a decision on future Scales of Contributions before December 2015, and for this purpose;

3. Tasks the OSCE Chairmanship to establish an open-ended, informal OSCE working group, in accordance with the Rules of Procedure of the OSCE, in particular paragraphs II(A)8–10 and paragraphs V(B)1–5;

The informal working group shall be led by a Chairperson appointed annually by the OSCE Chairmanship and shall perform the following tasks:

- To prepare a proposal for Scales of Contributions on the basis of reliable, verifiable and comparable data;
- To elaborate recommendations on a method of calculation for a periodic revision of the Scales of Contributions;
- To help build consensus for the adoption of revised Scales of Contributions and their periodic revision mechanism;

The recommendations of the informal working group to the Permanent Council shall be made, *inter alia*, in accordance with the following criteria:

- Gradual application of the principle of capacity to pay, based on the United Nations criteria for contributions;
- Political nature of the Organization;
- Revised level of the ceiling in the field operations scale for the contribution of any one participating State;
- A floor for the contribution of any one participating State;
- Revision of the scales every three years based on the above criteria and the current United Nations adjusted GNI figures;
- 4. Decides that the informal working group will start its work no later than March 2013;
- 5. Tasks the informal working group to provide respective progress reports to the Permanent Council by December 2013 and by December 2014, and to submit to the Permanent Council by 1 October 2015 the recommendations for the revised Scales of Contributions for the period covering 1 January 2016 to 31 December 2018.

INTERPRETATIVE STATEMENT UNDER PARAGRAPH IV.1(A)6 OF THE RULES OF PROCEDURE OF THE ORGANIZATION FOR SECURITY AND CO-OPERATION IN EUROPE

By the delegation of the United States of America:

"Thank you, Mr. Chairperson.

The United States wishes to make an interpretative statement under paragraph IV.1(A)6 of the Rules of Procedure of the Organization for Security and Co-operation in Europe.

In joining consensus on the Scales of Contributions for 2013–2015, the United States has made no commitment to any increases in the U.S. contribution beyond this period.

Permanent Council Decision No. 408, adopted in 2001, established a 14 per cent ceiling for the field operations (Vienna) scale. The logic behind that ceiling remains valid, and we see no reason for changing it. Furthermore, in the thirty-eight year after the Helsinki Accords were signed, we recall the significance of the concept of shared responsibilities (for both the Helsinki and Vienna scales), and intend to participate in discussions on that basis. Moreover, it remains our view that all the criteria applied to scales remain of equal weight.

The United States requests that this statement be recorded in the journal of the day.

DECISION No. 1073 APPROVAL OF THE 2013 UNIFIED BUDGET

The Permanent Council,

- I. Acting in accordance with the relevant provisions of the Financial Regulations and Permanent Council Decision No. 553 of 27 June 2003,
- 1. Approves the 2013 Unified Budget contained in Annex I;
- 2. Approves the Post Table contained in Annex II;
- II. Recalling relevant Ministerial Council Decisions, *inter alia*, No. 18/06 on further strengthening the effectiveness of OSCE executive structures and No. 19/06 on strengthening the effectiveness of the OSCE,

Taking into account Permanent Council Decision No. 705 of 1 December 2005 on the Common Regulatory Management System (CRMS), and striving to contribute to strengthening the efficiency, effectiveness and transparency of the Organization,

Underlining the importance of the oversight of the OSCE's administrative and financial activities exercised by the participating States, and recalling Permanent Council Decision No. 552 of 27 June 2003, setting out the responsibilities of the Advisory Committee on Management and Finance (ACMF), and

Taking into consideration financial constraints faced currently by the participating States and reiterating that any request for a supplementary budget during a financial year shall be met, wherever reasonable, by reallocating existing resources,

- 1. Tasks the ACMF, in co-ordination with the Secretary General, to continue efforts to improve further the programme and budget planning process within the OSCE;
- 2. Tasks the ACMF to continue deliberations on amending the OSCE Financial Regulations with the aim of achieving approval of new OSCE Financial Regulations;
- 3. Undertakes to continue efforts, including throughout the Unified Budget cycle in 2013, to focus, streamline and prioritize the work of the Organization across the three dimensions in those areas where it has comparative advantage, and tasks the fund

managers to ensure the coherence of their programme activities, in accordance with the body of OSCE principles, commitments and decisions as well as their respective mandates;

- 4. Recalling Permanent Council Decision No. 981 of 23 December 2010, decides to apply the OSCE methodology on calculation of the board and lodging allowances by using the 24 month moving average of the UN Retail Price Indexes with details available before submission of the Unified Budget Proposal for the following year;
- 5. Tasks the ACMF to submit recommendations with regard to Staff Standard Costs and human resource practices, in particular staff salaries and benefits, by
 1 September 2013, with a view to ensuring the long-term financial sustainability of these costs;
- 6. Tasks the ACMF to continue to review the augmentation practice and to report its preliminary findings to the Permanent Council by 1 August 2013;
- 7. Requests the Secretary General to comprehensively review the issue of local staff income tax in those locations where such tax is still charged, and to submit recommendations to the ACMF in consultation with the respective host countries by 1 July 2013 with a view to achieving full compliance with the Common Regulatory Management System.

INTERPRETATIVE STATEMENT UNDER PARAGRAPH IV.1(A)6 OF THE RULES OF PROCEDURE OF THE ORGANIZATION FOR SECURITY AND CO-OPERATION IN EUROPE

By the European Union:

"The European Union Member States thank the Ukrainian Chairmanship for its outstanding work and all of its efforts that made it possible to adopt the Unified Budget for 2013. However, we regret the delay in adopting the budget, when we had been willing to accept the Chairmanship's proposal of 28 December despite our great reluctance to join the consensus.

The work of the OSCE's three independent institutions, which are dealing with ever more requests for co-operation from the participating States, needs unwavering support. For the next budget cycle, we aspire to ensuring that the Unified Budget resources earmarked for the Office for Democratic Institutions and Human Rights, the Representative on Freedom of the Media and the High Commissioner on National Minorities correspond to the growing demands in these areas. The oft-repeated desire of certain participating States to challenge the institutions' mandates, including through budget negotiations, is a particular cause for concern.

It is regrettable that no consensus could be reached on an ambitious budget as regards appropriations for the resolution of protracted conflicts or for the implementation of Ministerial Council Decision No. 3/11, adopted in Vilnius, on elements of the conflict cycle, especially in relation to early action.

The initiatives undertaken by the field missions in south-eastern Europe to make savings through significant reorganization efforts, especially with regard to administrative costs, are to be welcomed and continued.

With regard to Central Asia, we remain convinced that the growing security challenges in the three dimensions mean that more appropriate financial and human resources need to be allocated to the field missions."

The acceding country Croatia¹, the candidate countries the former Yugoslav Republic of Macedonia¹, Montenegro¹, Iceland² and Serbia¹, the Stabilisation and Association Process and potential candidate countries Albania and Bosnia and Herzegovina, the European Free Trade Association country Liechtenstein and the Republic of Moldova, Georgia and San Marino align themselves with this statement.

Croatia, the former Yugoslav Republic of Macedonia, Montenegro and Serbia continue to be part of the Stabilisation and Association Process.

INTERPRETATIVE STATEMENT UNDER PARAGRAPH IV.1(A)6 OF THE RULES OF PROCEDURE OF THE ORGANIZATION FOR SECURITY AND CO-OPERATION IN EUROPE

By the delegation of the United States of America:

"Mr. Chairperson,

The United States would like to make the following interpretative statement under paragraph IV.1(A)6 of the Rules of Procedure of the Organization for Security and Co-operation in Europe.

The United States sincerely thanks Ukraine, in particular Ukraine's ACMF chairperson Ms. Victoria Kuvshynnykova, for its hard work and leadership on the budget this year. Without your dedication, we would not have this agreement today.

Again this year, the United States has joined consensus on the 2013 Unified Budget not because we are happy with the budget we have just passed, but because we believe that the Organization needs a sound budgetary footing to move ahead with programmes and activities.

We are, in fact, disappointed that participating States have not been able to find consensus and provide funding for a number of important activities that would help the OSCE maintain its relevance as a regional organization that addresses challenges of the 21st Century and promotes the comprehensive security of its participating States. The Border Management Staff College in Dushanbe is engaged in meaningful work with border and customs officials from across the OSCE. I regret to say that we are concerned for its future given that no funding is provided for its operations in this Unified Budget. In addition, we find no logic in limiting the OSCE's ability to address the threat of proliferation of weapons of mass destruction and their means of delivery by blocking funding for UNSCR 1540 work in this budget. We recognize that the vast majority of participating States understood the importance of and supported the funding for these two programmes.

We agree fully with the reductions in funding for field missions in South-Eastern Europe, where the security situation has improved significantly over the years of OSCE engagement in that region. On the other hand, we continue to believe that the growing challenges in Central Asia warrant greater budgetary increases in that part of the OSCE space. We regret that participating States could not find consensus on larger increases there, and we will continue to seek adjustments to the budget in future years to better reflect current realities and challenges to security.

In 2013, we hope to see movement toward resolution of the protracted conflicts, a long-standing priority for the OSCE. The United States supported additional funding and personnel, for example for the Mission in Moldova, to help achieve progress.

The budgets of the institutions, the Office for Democratic Institutions and Human Rights, the High Commissioner on National Minorities, and the Representative for Freedom of the Media, were subject to undue scrutiny and micromanagement this year during the budget negotiations. They operate according to the mandates participating States have approved, and should be given the latitude and resources needed to fulfil their mandates to the best of their abilities. We could not agree to cuts in their budgets, and, in fact, we believe this budget still falls short of their needs for 2013.

Finally, we will continue to place emphasis on strong project assessment and evaluation to demonstrate the impact of OSCE activities. We encourage the Secretariat to share more of its internal evaluations as well, to help us make the case for funding to support OSCE priorities.

The United States requests that this statement be recorded in the journal of the day.

INTERPRETATIVE STATEMENT UNDER PARAGRAPH IV.1(A)6 OF THE RULES OF PROCEDURE OF THE ORGANIZATION FOR SECURITY AND CO-OPERATION IN EUROPE

By the delegation of Norway (also on behalf of Switzerland):

"Mr. Chairperson,

I would like to make the following interpretative statement on behalf of Switzerland and Norway and according to paragraph IV.1(A)6 of the OSCE Rules of Procedure.

We thank you, Mr. Chairperson, and the Chairperson of the ACMF for your tireless efforts to form consensus on the 2013 Unified Budget. We regret, however, that for the first time since 2008 we were unable to adopt the budget in time.

The primary responsibility for the late approval of the budget has to be carried by the Russian Federation. Already in December we had a proposal that represented a compromise that should have been acceptable to all of us.

As we all know, the budget decision was made possible through extrabudgetary contributions from Kazakhstan, Switzerland, Turkey and Norway.

Switzerland and Norway did not contribute because we thought that the project now to be carried out by the ODIHR is of particular importance. Nor do we approve of the way in which it has been promoted.

Our primary concern was the detrimental effects to our Organization of the situation in which we found ourselves.

We would also like to note that we would have liked to see a more co-operative and pragmatic approach from other participating States which usually share our human dimension priorities.

Mr. Chairperson,

We live in times of increasing uncertainty. We are faced with challenges in all three dimensions. The OSCE has the instruments to assist us in meeting these challenges. Therefore, we are particularly disappointed with the low level of funding now allocated to the Office for Democratic Institutions and Human Rights, the High Commissioner on National Minorities and the Representative on Freedom of the Media.

We are also disappointed that requests for more human resources in some of the field missions in Central Asia were not met.

Looking ahead, we should also make sure that we have the necessary resources to re-establish a presence in Belarus and Georgia and to establish some kind of OSCE presence in Mongolia.

Mr. Chairperson,

Our Organization derives its effectiveness in large part from the expertise and motivation of its staff. The key to maintain a high level of performance is our ability to retain and attract qualified staff. For this reason, we have during the budget negotiations strongly argued in favour of maintaining a remuneration policy that is compatible with those of comparable employers.

Mr. Chairperson,

Ten years ago, in 2003, the OSCE had a budget of 170 million euros. Adjusted for an average consumer price index increase, that would in 2013 amount to approximately 225 million. The budget we have just approved has a balance of less than 145 million.

The OSCE has over these ten years lost a lot of its strength and capacity. We do not believe this is the direction in which our Organization should be going.

Mr. Chairperson, I request that this statement be attached to the journal of today's meeting.
